- I. 1984 Represented Bangladesh in a 35 nations' tour to the EEC Headquarters, Brussels, Belgium – meeting with the Director General for Commerce & Industry, European Economic Community. General introduction was given to the visiting delegates by His Excellency Mr. Arther Poolay, Secretary General of the European Economic Commission. Later, discussion on economic and trade issues was held with the EEC officials headed by His Excellency Mr. Geoffrey Charatan, Director General, Development of the EEC. Apprised and brought his kind attention to the flat rate of export quota for readymade garments (RMG) into the EEC and its negative consequent impacts, especially to the populous countries like Bangladesh which was the eighth largest country with a population of 120 million. Under the EEC quota she was permitted to export the same volume of RMG equivalent to such smaller countries like Congo or Ghana - whose population were merely 2 million. This important initiative of making quota disparity an issue for further discussion to eliminate the quota disparity was highly appreciated by the DG, EEC. In his concluding speech, H.E. Mr. Geoffrey Charatan with his discretionary power instantly declared a temporary solution to RMG guota disparity till the amendment of the flat rate of RMG quota to the EEC. As per his instant instruction, any quota depleted country/s, before the end of each guota-year, was allowed to utilize those unutilized yearly guota of other countries. H.E. Mr. Geoffrey Charatan further promised to raise the issue formally in the highest body of the EEC to give a permanent solution to the RMG quota issue. This initiative subsequently helped to waive Bangladesh's quota restriction of RMG to the countries of the European Economic Community.
